
## Installation

### Hardware Installation

1. Connect a **CAT5/6a Cable** to the **RJ45 Port** on the **Network Adapter** and to a **Network Device**.
2. Connect the **USB-C Connector** on the **Network Adapter** to a USB-C port on the **Host Computer**.

### Driver Installation

1. If the **Drivers** do not automatically download when you connect the **Network Adapter** to the **Host Computer**, a message that a **Virtual CD** is loaded will appear.
2. Click on the message, the **CD Drive** screen will open.

3. Click on the folder that is compatible with your **Host Computer** and run the **RTK\_NIC\_DRIVER\_INSTALLER** file to begin the background installation.
